1. Residents must have a pool tag to enter the pool facility. Anyone under the age of 10 years will not be allowed to enter the pool without a parent and the parent **MUST** stay at the pool the entire time the child is in the pool area.
2. Only Residents and/or guests of Residents will be permitted to use the pool.
3. Residents must be current on annual homeowners association maintenance fees in order to receive pool tags.
4. Pool rules will be posted at the pool. All swimmers must obey the lifeguards and comply with the pool rules posted at the pool.
